<b>ALTERNATIVE TRANSPORTATION SERVICES OF CHICAGOLAND</b>	<b>I-GO for Job Access</b> I-GO provides low emission cars on an hourly rental basis to members of the organization throughout the Chicago area. Low income job seekers will be able to obtain subsidized car rentals for job related trips. This project will be coordinated with the efforts of work force development agencies.	<b>\$ 161,507*</b>
<b>CTA</b>	<b>ROUTE # 53A SOUTH PULASKI</b> An expansion of this route's service frequency and expanded hours will provide improved access to a major medical center and retail establishments. These destinations provide employment opportunities for low-income individuals.	<b>\$ 255,307*</b>
<b>CTA</b>	<b>ROUTE # 18 16<sup>TH</sup>/18<sup>TH</sup> MIDDAY SERVICE</b> This service from 9 am to 2 pm weekdays will operate between 16 <sup>th</sup> /Cicero and Cermak/Indiana helping low income individuals obtain improved access to employment opportunities including two hospitals.	<b>\$ 464,051*</b>
<b>CTA</b>	<b>NEW CLYBOURN STREET FIXED ROUTE SERVICE</b> This is a new fixed route service connecting the Chicago Red Line and Logan Square Blue Line stations. There are an estimated 400-600 businesses on the route that represent employment opportunities for low-income workers. A major attraction on this route is the Anixter Center that provides training and employment for persons with severely limited mobility.	<b>\$ 2,179,843*</b>
<b>Metra</b>	<b>METRA SUNRISE EXPRESS</b> This is for the second year of funding for the Sunrise Express early morning reverse commute train operating on the Metra UP North Line from Chicago to Waukegan. The service enables reverse commuters to meet 7 am work start times of north suburban employers. Other benefits include a viable suburb-to-suburb option for commuters living north of Chicago and an additional inbound train. According to Metra, the service is averaging a daily ridership of 275 passengers with 77 or 28% of them estimated to be low income.	<b>\$ 179,000</b>
<b>PACE</b>	<b>Centralized Call Center</b> This is the first phase of a three-part plan to implement one of three regional call centers. The center will promote, enhance and facilitate access to transportation services, including the integration and coordination of services for individuals with disabilities, older adults and those individuals with low income. Facilitating the coordination of transportation services for work training work shops and work placement agencies are among the functions of the call center.	<b>\$ 186,477</b>

<b>KENDALL COUNTY</b>	<b>KENDALL COMMUNITY TRANSIT PROGRAM</b> The vehicles and operations funded by this program will be used for demand responsive paratransit service to provide door-to-door service for populations of the disabled, low income, and senior populations in the urban portions of Kendall County. The project is designed to be the first phase of a countywide general public transportation system.	<b>\$ 519,300</b>
<b>PACE</b>	<b>CENTRALIZED CALL CENTER</b> This is the first phase of a three-part plan to implement one of three regional call centers. Funding from this program will support mobility management and dispatching functions for the estimated 10,000 disabled individuals expected to utilize the call center annually. The center will promote, enhance and facilitate access to transportation services, including the integration and coordination of services for individuals with disabilities, older adults and those individuals with low income.	<b>\$ 1,600,108</b>
<b>RAY GRAHAM ASSOCIATION FOR PEOPLE WITH DISABILITIES</b>	<b>SAFETY TRANSPORTATION TRAINING PROGRAM</b> The project will assess and provide training to the disabled and older adults to improve their ability to utilize transportation services.	<b>\$ 34,725</b>
